Northwest District voted in 2009 that it would be left up to the District President and District Choral chair as to whether a student may be allowed into the district choir if a teacher missed the deadline.
  - Kathy stated it has been advised our district take this issue up with the State KMEA.
- B. A question was raised regarding why the choir system for State is not the same as the band. Band members may pay a late fee clear up until the time of auditions.

It is recommended from the Northwest District that New District President-Vesta Jo Still take to the State KMEA Board meeting our concern and permission to allow students in the District Honor Choir only- if a teacher or unforeseen circumstances exist. The District President and Choral Chair would review the circumstances and determine if the entry should be allowed.
