#### V. New Business

A. Vote for Acceptance of the Bylaws and Policies-Connie Reishus- NW Executive Director Connie explained that with the help of Stacey Williams and John Taylor-State Executive Director, she was able to put the Northwest District Handbook together. She used the State KMEA handbook as a guide. There are three sections to the handbook-1)By-laws, 2)Job Descriptions and 3)Policies.

- 1. By-laws require full membership only to vote for changes.
- 2. Elections of officers and Board members require full membership vote.
- 3. Policy-fees and other items under policy can be voted on by the Board of Directors.
- 4. Connie stated that a copy of the handbook was put online in August for all Northwest District members to view. She stated there are a few changes which were given by members. At this time she listed these changes
- 5. If the handbook is passed by everyone today then chairs of committees will need to be voted on by full membership. Per Article V-Elections- Section 2-District Election of Officers- members of the Board of Directors must be voted on by full membership. Kayla will have ballots for you to vote for the chairs.
- 6. Next year when the President-elect is elected the chairs will nominate their assistants to serve as the new chairs and will be voted on by the full membership. They will take effect after the ISW in February.
