Joey suggested these scholarships are available and if any teachers in Northwest knew of someone deserving of any of these please submit their names.

#### **5. Instrumental auditions**

- a. 4<sup>th</sup> year audition cycle should be ready a year from now in 2022.
- b.Discussion on removing the major scales from band and orchestra live auditions.
  - 1. Joey asked what Northwest Districts thoughts were on this. The rationale was that the chromatic scale shows total range of students as well as tone in those ranges. It was confusing on the major scales as to whether it was the scale of the instrument or the concert scale. Most board members felt the chromatic was sufficient.
- c. Complete percussion audition for state
  - 1. Students auditioning would have to audition on snare, mallet and timpani in order to audition for state.

A discussion was held on this matter and a lot of board members <u>felt timpani should not be included</u> as a lot of schools do not have 4 timpani or even good timpani. Also, a teacher could have their best timpani player assigned to another group. It is the responsibility of the state band chair to figure out how many percussionists needed.

- 2. A committee was formed to look into this
  - a. Chaired by Dan Freeman of the East Central District
  - b. Joey represents Northwest District

- d. KBA has been asked to create a more standardized process to provide equity and avoid copyright concerns by looking into creating a 4 year band rotation of audition music for the All State Bands that is based on original compositions and prescribed scale study pages.
  - 1. Jazz and orchestra just went through this process and it will provide best practices for the organization as well as the schools.

### 6. State President, Mark Gard's Strategic Plan

- a. Access to Music
- b. Student Involvement Opportunities-More Tri-M chapters and the state will pay half of the fee to join
- c. Professional Development

#### 7. Kansas School Redesign

a. Joey asked if there were any board members schools in the redesign program and if so how was it affecting electives. Annie Adams stated she had talked to teachers in schools that had the redesign and it is affecting electives. Initially music was to be in the redesign but was later taken out.

#### **8. KCDA**

a. Is there interest in 4A-6A large ensembles preparing 3 pieces for regional music contests instead of 4.
What is happening now is 4 pieces are prepared and then The day of contest one is thrown out. NW teachers felt only three should be prepared and performed.

# 9. KMEA & KMTA

a. KMTA will no longer be allowed to attend KMEA ISW on KMTA memberships only. They will have to join NAfME. Right now there is no way of knowing who has a current membership in KMTA.

# 10. <u>KSDE</u>

a. Joyce Huser (KSDE rep) is wondering about doing Standard revisions not for K-8 or ensembles but for Guitar, Music Tech and music not common in the Classroom.

#### 11. KMR (Kansas Music Review submissions

- a. District will do a state update at some point in the year.
- b. They are always looking for contributions from members
- c. Joey stated let's highlight the great things happening in the NW district.

#### 12. 12A Honor Band (ISW 2022)

- a. This is not an All-State group
- b. Students must audition for district band to be eligible
- c. It is created after state band auditions happen in January
- d. Teachers will nominate student
- e. Will help provide opportunities for students in the 180 12A schools
- f. Ed Huckeby will be the clinician in 2022
- g. Vesta Jo Stilll is the chair for the 12A Honor Band.

#### 13. Liability Insurance

- a. KMEA purchases liability insurance through NAfME
  - 1. Covers lawsuits brought against leaders for decisions made as part of Board service.
  - 2. It is a gift KMEA is giving to District and Affiliate Boards. Any person who is elected to the Board and is a voting member is covered.
